Axcelis Technologies, Inc. (ACLS) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each ACLS Common Share will be converted into the right to receive 0.25 (New) Axcelis Technologies, Inc. (ACLS) Common Shares. The reverse stock split will become effective at the market open on July 1, 2016.
