On June 21, 2018, Shareholders of Analogic Corporation (ALOG) voted concerning the proposed merger with a wholly-owned subsidiary of ANLG Holding Company, Inc., both beneficially owned by affiliates of Altaris Capital Partners, LLC. The merger was approved and subsequently consummated on June 22, 2018. As a result, each existing ALOG Common Share will be converted into the right to receive \$84.00 net cash per share.

Settlement in ALOG options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Analogic Corporation options whose expiration dates are after 07-20-2018 will have their expiration dates advanced to 07-20-2018. Expiration dates occurring before 07-20-2018 (e.g., Flex options) will remain unchanged.

All Analogic Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 07-20-2018

Existing American-style Analogic Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
