On March 12, 2021, Shareholders of Alaska Communications Systems Group, Inc. (ALSK) voted concerning the proposed merger with a wholly-owned subsidiary of Project 8 Buyer, LLC, an affiliate of ATN International, Inc. and Freedom 3 Investments IV, LP. The merger was approved and subsequently consummated on July 22, 2021. As a result, each existing ALSK Common Share will be converted into the right to receive \$3.40 net cash per share.

## **CONTRACT ADJUSTMENT**

PER CONTRACT: \$340.00 Cash (\$3.40 x 100)

Settlement in ALSK options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Alaska Communications Systems Group, Inc. options whose expiration dates are after 8-20-2021 will have their expiration dates advanced to 8-20-2021. Expiration dates occurring before 8-20-2021 (e.g., Flex options) will remain unchanged.

All Alaska Communications Systems Group, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Alaska Communications Systems Group, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
