The Options Clearing Corporation (OCC) has been informed that Aegean Marine Petroleum Network Inc. (ANW) will change its trading symbol to ANWWQ, due to the listing of the company on an OTC market. As a result, option symbol ANW will change to ANWWQ effective at the opening of business on November 7, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol ANWWQ commencing November 7, 2018.
