Actinium Pharmaceuticals, Inc. (ATNM) has announced a 1-for-30 reverse stock split. As a result of the reverse stock split, each ATNM Common Share will be converted into the right to receive approximately 0.033333 (New) Actinium Pharmaceuticals, Inc. Common Shares. The reverse stock split will become effective before the market open on August 11, 2020. Cash will be paid in lieu of fractional shares.

Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
