The Options Clearing Corporation (OCC) has been informed that Bill Barrett Corporation (BBG) will change its name, trading symbol and CUSIP to High Point Resources Corporation (HPR), CUSIP 43114K108, in conjunction with the merger with Fifth Creek Energy Operating Company, LLC. As a result, option symbol BBG will also change to HPR effective at the opening of business on March 20, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol HPR commencing March 20, 2018.
