The Options Clearing Corporation (OCC) has been informed that BlackBerry Limited (BBRY) will change its trading symbol to BB, effective October 16, 2017. As a result, option symbol BBRY will also change to BB effective at the opening of business on October 16, 2017.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol BB commencing October 16, 2017.
