The Options Clearing Corporation (OCC) has been informed that BB&T Corporation (BBT) will change its name, trading symbol and CUSIP to Truist Financial Corporation (TFC), CUSIP 89832Q109. As a result, option symbols BBT/2BBT will also change to TFC/2TFC effective at the opening of business on December 9, 2019.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols TFC/2TFC commencing December 9, 2019.
