On January 9, 2018, Shareholders of Bob Evans Farms, Inc. (BOBE) voted concerning the proposed merger with Haystack Corporation, a wholly-owned subsidiary of Post Holdings, Inc. The merger was approved and subsequently consummated before the open on January 12, 2018. As a result, each existing BOBE Common Share will be converted into the right to receive \$77.00 net cash per share.

CONTRACT ADJUSTMENT

DATE: January 12, 2018

NEW DELIVERABLE

PER CONTRACT: \$7,700.00 Cash (\$77.00 x 100)

Settlement in BOBE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Bob Evans Farms, Inc. options whose expiration dates are after 01-19-2018 will have their expiration dates advanced to 01-19-2018. Expiration dates occurring before 01-19-2018 (e.g., Flex options) will remain unchanged.

All Bob Evans Farms, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: BOBE

Existing Expiration: All months New expiration date: 01-19-2018

Existing American-style Bob Evans Farms, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
