ProShares Ultra Bloomberg Natural Gas (BOIL) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each BOIL Share will be converted into the right to receive 0.20 (New) ProShares Ultra Bloomberg Natural Gas (BOIL) Shares. The reverse stock split will become effective before the market open on March 20, 2018.
