## SUBJECT: CASCADIAN THERAPEUTICS, INC. – CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS OPTION SYMBOL: CASC DATE: 3/9/18

On March 9, 2018, Valley Acquisition Sub, Inc., a wholly owned subsidiary of Seattle Genetics, Inc. completed its tender offer for Cascadian Therapeutics, Inc. (CASC) Common Shares. The merger was subsequently consummated before the open on March 9, 2018. As a result, each existing CASC Common Share will be converted into the right to receive \$10.00 net cash per share.

### **CONTRACT ADJUSTMENT**

NEW DELIVERABLEPER CONTRACT:\$1,000.00 Cash (\$10.00 x 100)

Settlement in CASC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Cascadian Therapeutics, Inc. options whose expiration dates are after 03-16-2018 will have their expiration dates advanced to 03-16-2018. Expiration dates occurring before 03-16-2018 (e.g., Flex options) will remain unchanged.

All Cascadian Therapeutics, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: CASC Existing Expiration: All months New expiration date: 03-16-2018

Existing American-style Cascadian Therapeutics, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
