Depomed, Inc. (DEPO) will change its name, trading symbol, and CUSIP to Assertio Therapeutics, Inc. (ASRT), CUSIP 04545L107. As a result, option symbol DEPO will also change to ASRT, effective at the opening of business on August 15, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol ASRT commencing August 15, 2018.
