Diginex Limited (DGNX) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each DGNX Ordinary Share will be converted into the right to receive 0.125 (New) Diginex Limited Ordinary Shares. The reverse stock split will become effective before the market open on April 28, 2026. Fractional shares will be rounded up to the next whole share.
