BACKGROUND

Dover Corporation (DOV) has announced a distribution of (New) Apergy Corporation (APY) Common Shares. The distribution ratio is 0.5 of an APY share for each DOV share held. The record date is April 30, 2018; the payable date is May 9, 2018. The New York Stock Exchange (NYSE) has set May 9, 2018 as the ex-distribution date for this distribution.

Apergy Corporation Common Shares began trading on a when issued basis on April 27, 2018 on the NYSE under the trading symbol "APY WI".
