On April 15, 2019, Shareholders of Ellie Mae, Inc. (ELLI) voted concerning the proposed merger with a wholly-owned subsidiary of EM Eagle Purchaser, LLC, an affiliate of Thoma Bravo, LLC. the merger was approved and subsequently consummated before the open on April 17, 2019. As a result, each existing ELLI Common Share will be converted into the right to receive \$99.00 net cash per share.

**CONTRACT ADJUSTMENT**

**NEW DELIVERABLE  
PER CONTRACT:** \$9,900.00 Cash (\$99.00 x 100)

Settlement in ELLI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Ellie Mae, Inc. options whose expiration dates are after 5-17-2019 will have their expiration dates advanced to 5-17-2019. Expiration dates occurring before 5-17-2019 (e.g., Flex options) will remain unchanged.

All Ellie Mae, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: ELLI  
Existing Expiration: All months  
New expiration date: 5-17-2019

Existing American-style Ellie Mae, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
