ProShares Ultra Ether ETF (EHTH) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each EHTH share will be converted into the right to receive 0.2 (New) ProShares Ultra Ether ETF shares. The reverse stock split will become effective before the market open on June 12, 2025.
