On July 12, 2017, Shareholders of Fortress Investment Group LLC (FIG) voted concerning the proposed merger with Foundation Acquisition LLC, a wholly-owned subsidiary of SB Foundation Holdings LP. The merger was approved and subsequently consummated before the open on December 27, 2017. As a result, each existing FIG Common Class A Share will be converted into the right to receive \$8.08 net cash per share.

## **CONTRACT ADJUSTMENT**

NEW DELIVERABLE

PER CONTRACT: \$808.00 Cash (\$8.08 x 100)

Settlement in FIG options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Fortress Investment Group LLC options whose expiration dates are after 01-19-2018 will have their expiration dates advanced to 01-19-2018. Expiration dates occurring before 01-19-2018 (e.g., Flex options) will remain unchanged.

All Fortress Investment Group LLC (FIG) options will utilize a \$.01 exercise threshold.

Option Symbol: FIG

Existing Expiration: All months New expiration date: 01-19-2018

Existing American-style Fortress Investment Group LLC (FIG) options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
