On **September 5, 2017** Fuel Acquisition Co., a wholly owned subsidiary of Sizmek Inc., completed its tender offer for Rocket Fuel Inc. (FUEL) Common Shares. The subsequent merger was completed before the open on September 6, 2017. As a result, each existing FUEL Common Share will be converted into the right to receive \$2.60 net cash per share.

## **CONTRACT ADJUSTMENT**

NEW DELIVERABLE

PER CONTRACT: \$260.00 Cash (\$2.60 x 100)

Settlement in FUEL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Rocket Fuel Inc. options whose expiration dates are after 9-15-2017 will have their expiration dates advanced to 9-15-2017. Expiration dates occurring before 9-15-2017 (e.g., Flex options) will remain unchanged.

All Rocket Fuel Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: FUEL

Existing Expiration: All months New expiration date: 9-15-2017

Existing American-style Rocket Fuel Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
