On August 29, 2019, Shareholders of Hydrogenics Corporation (HYGS) voted concerning the proposed Plan of Arrangement with Atlantis AcquisitionCo Canada Corporation, a wholly-owned subsidiary of Cummins Inc. The Arrangement was approved and subsequently consummated before the open on September 9, 2019. As a result, each existing HYGS Common Share will be converted into the right to receive \$15.00 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLEPER CONTRACT:\$1,500.00 Cash (\$15.00 x 100)

Settlement in HYGS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Hydrogenics Corporation. options whose expiration dates are after 9-20-2019 will have their expiration dates advanced to 9-20-2019. Expiration dates occurring before 9-20-2019 (e.g., Flex options) will remain unchanged.

All Hydrogenics Corporation will utilize a \$.01 exercise threshold.

Option Symbols: HYGS Existing Expiration: All months New expiration date: 9-20-2019 Existing American-style Hydrogenics Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
