On May 17, 2017, Shareholders of InvenSense, Inc. (INVN) voted concerning the proposed merger with TDK Sensor Solutions Corporation, an indirect wholly-owned subsidiary of TDK Corporation. The merger was approved and subsequently consummated before the open on May 18, 2017. As a result, each existing INVN Common Share will be converted into the right to receive \$13.00 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLE

PER CONTRACT: \$1,300.00 Cash (\$13.00 x 100)

Settlement in INVN options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of InvenSense, Inc. options whose expiration dates are after 6-16-2017 will have their expiration dates advanced to 6-16-2017. Expiration dates occurring before 6-16-2017 (e.g., Flex options) will remain unchanged.

All InvenSense, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 6-16-2017

Existing American-style InvenSense, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
