Tradr 2X Long IREN Daily ETF (IREX) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each IREX Share will be converted into the right to receive approximately 0.333333 (New) Tradr 2X Long IREN Daily ETF Shares. The reverse stock split will become effective before the market open on March 10, 2026. Cash will be paid in lieu of fractional shares.

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for IREX1 will be determined as follows:

$$\text{IREX1} = 0.333333 (\text{IREX})$$

Delayed Settlement

The IREX component of the IREX1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the IREX1 deliverable until the cash in lieu of fractional IREX Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
