On August 13, 2018, Catalent Boston, Inc., a wholly owned subsidiary of Catalent Pharma Solutions, Inc. completed its tender offer for Juniper Pharmaceuticals, Inc. (JNP) Common Shares. The subsequent merger was completed before the open on August 14, 2018. As a result, each existing JNP Common Share will be converted into the right to receive \$11.50 net cash per share.

CONTRACT ADJUSTMENT

PER CONTRACT: \$1,150.00 Cash (\$11.50 x 100)

Settlement in JNP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Juniper Pharmaceuticals, Inc. options whose expiration dates are after 08-17-2018 will have their expiration dates advanced to 08-17-2018. Expiration dates occurring before 08-17-2018 (e.g., Flex options) will remain unchanged.

All Juniper Pharmaceuticals, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months
New expiration date: 08-17-2018

Existing American-style Juniper Pharmaceuticals, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
