On October 19, 2016, Shareholders of Joy Global Inc. (JOY) voted concerning the proposed merger with Pine Solutions Inc., a wholly-owned subsidiary of Komatsu America Corporation. The merger was approved and subsequently consummated on April 5, 2017. As a result, each existing JOY Common Share will be converted into the right to receive \$28.30 net cash per share.

CONTRACT ADJUSTMENT

DATE: April 6, 2017

NEW DELIVERABLE

PER CONTRACT: \$2,830.00 Cash (\$28.30 x 100)

Settlement in JOY options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Joy Global Inc. options whose expiration dates are after 4-21-2017 will have their expiration dates advanced to 4-21-2017. Expiration dates occurring before 4-21-2017 (e.g., Flex options) will remain unchanged.

All Joy Global Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: JOY

Existing Expiration: All months New expiration date: 4-21-2017

Existing American-style Joy Global Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
