On March 2, 2018, Blue Magpie Corporation, a wholly-owned subsidiary of Celgene Corporation, completed its tender offer for Juno Therapeutics, Inc. (JUNO) Common Shares. The merger was subsequently consummated before the open on March 6, 2018. As a result, each existing JUNO Common Share will be converted into the right to receive \$87.00 net cash per share.

CONTRACT ADJUSTMENT

PER CONTRACT: \$8,700.00 Cash (\$87.00 x 100)

Settlement in JUNO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Juno Therapeutics, Inc. options whose expiration dates are after 03-16-2018 will have their expiration dates advanced to 03-16-2018. Expiration dates occurring before 03-16-2018 (e.g., Flex options) will remain unchanged.

All Juno Therapeutics, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Juno Therapeutics, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
