The Options Clearing Corporation (OCC) has been informed that Liberty Interactive Corporation series A (LVNTA) will change its name, trading symbol and CUSIP to GCI Liberty, Inc. class A (GLIBA), CUSIP 36164V305. As a result, option symbol LVNTA will also change to GLIBA effective at the opening of business on March 12, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol GLIBA commencing March 12, 2018.
