Tradr 2X Short NBIS Daily ETF (NBIZ) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each NBIZ share will be converted into the right to receive approximately 0.333333 (New) Tradr 2X Short NBIS Daily ETF Shares. The reverse stock split will become effective before the market open on July 21, 2026. Cash will be paid in lieu of fractional shares.

Contract Adjustment

Option Symbol: NBIZ changes to NBIZ2

Contract Multiplier: 1

Pricing

Until the cash in lieu amount is determined, the underlying price for NBIZ2 will be determined as follows:

$$\text{NBIZ2} = 0.333333 (\text{NBIZ})$$

Delayed Settlement

The NBIZ component of the NBIZ2 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the NBIZ2 deliverable until the cash in lieu of fractional NBIZ Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
