Noranda Aluminum Holding Corporation (NOR) has announced a 1-for-7 reverse stock split. As a result of the reverse stock split, each NOR Common Share will be converted into the right to receive approximately 0.142857 (New) Noranda Aluminum Holding Corporation Common Shares. Fractional shares will be rounded up to the nearest share. The reverse stock split will become effective at the market open on August 26, 2015.
