Tradr 1.5X Short NVDA Daily ETF (NVDS) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each NVDS Share will be converted into the right to receive approximately 0.333333 (New) Tradr 1.5X Short NVDA Daily ETF Shares. The reverse stock split will become effective before the market open on October 21, 2025. Cash will be paid in lieu of fractional shares.

Delayed Settlement

The NVDS component of the NVDS2 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the NVDS2 deliverable until the cash in lieu of fractional NVDS Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
