On November 29, 2017, Shareholders of Orbital ATK, Inc. (OA) voted concerning the proposed merger with Neptune Merger, Inc., a wholly owned subsidiary of Northrop Grumman Corporation. The merger was approved and subsequently consummated on June 6, 2018. As a result, each existing OA Common Share will be converted into the right to receive \$134.50 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLE

PER CONTRACT: \$13,450.00 Cash (\$134.50 x 100)

Settlement in OA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Orbital ATK, Inc. options whose expiration dates are after 06-15-2018 will have their expiration dates advanced to 06-15-2018. Expiration dates occurring before 06-15-2018 (e.g., Flex options) will remain unchanged.

All Orbital ATK, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 06-15-2018

Existing American-style Orbital ATK, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
