The Options Clearing Corporation (OCC) has been informed that Bank of the Ozarks (OZRK) will change its name, trading symbol and CUSIP to Bank OZK (OZK), CUSIP 06417N103. As a result, option symbol OZRK will also change to OZK effective at the opening of business on July 16, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol OZK commencing July 16, 2018.
