On March 10, 2020, Shareholders of Pattern Energy Group Inc. (PEGI) voted concerning the proposed merger with a wholly-owned subsidiary of Pacific US Inc., which is a wholly-owned by Canada Pension Plan Investment Board. The merger was approved and subsequently consummated before the open on March 16, 2020. As a result, each existing PEGI Class A Common Share will be converted into the right to receive \$26.75 net cash per share.

## **CONTRACT ADJUSTMENT**

NEW DELIVERABLE

PER CONTRACT: \$2,675.00 Cash (\$26.75 x 100)

Settlement in PEGI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series (See OCC Information Memo 23988). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Pattern Energy Group Inc. options whose expiration dates are after 3-20-20 will have their expiration dates advanced to 3-20-20. Expiration dates occurring before 3-20-20 (e.g., Flex options) will remain unchanged.

All Pattern Energy Group Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New Expiration date: 3-20-20

Existing American-style Pattern Energy Group Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
