CPI Card Group Inc. (PMTS) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each PMTS Common Share will be converted into the right to receive 0.20 (New) CPI Card Group Inc. Common Shares. The reverse stock split will become effective before the market open on December 20, 2017.
