The Options Clearing Corporation (OCC) has been informed that pSivida Corporation (PSDV) will change its name, trading symbol and CUSIP to EyePoint Pharmaceuticals, Inc. (EYPT), CUSIP 30233G100. As a result, option symbol PSDV will also change to EYPT effective at the opening of business on April 2, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol EYPT commencing April 2, 2018.
