Polestar Automotive Holding UK PLC (PSNY) has announced a 1-for-30 reverse stock split. As a result of the reverse stock split, each PSNY Class A American Depositary Share will be converted into the right to receive approximately 0.033333 (New) Polestar Automotive Holding UK PLC Class A American Depositary Shares. The reverse stock split will become effective before the market open on December 9, 2025. Cash will be paid in lieu of fractional shares.

Until the cash in lieu amount is determined, the underlying price for PSNY1 will be determined as follows:

PSNY1 = 0.033333 (PSNY)

Delayed Settlement

The PSNY component of the PSNY1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the PSNY1 deliverable until the cash in lieu of fractional PSNY Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
