On February 13, 2018, Sun Acquisition Co., a wholly owned indirect subsidiary of Mallinckrodt Public Limited Company, completed its tender offer for Sucampo Pharmaceuticals, Inc. (SCMP) Class A Common Shares. The subsequent merger was completed before the open on February 13, 2018. As a result, each existing SCMP Class A Common Share will be converted into the right to receive \$18.00 net cash per share.

## **CONTRACT ADJUSTMENT**

Settlement in SCMP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Sucampo Pharmaceuticals, Inc. options whose expiration dates are after 2-16-2018 will have their expiration dates advanced to 2-16-2018. Expiration dates occurring before 2-16-2018 (e.g., Flex options) will remain unchanged.

All Sucampo Pharmaceuticals, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: SCMP

Existing Expiration: All months New expiration date: 2-16-2018

Existing American-style Sucampo Pharmaceuticals, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
