SUBJECT: SONIC CORPORATION – CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS OPTION SYMBOL: SONC DATE: 12/7/18

On December 6, 2018, Shareholders of Sonic Corporation (SONC) voted concerning the proposed merger with SSK Merger Sub, Inc., a directly wholly-owned subsidiary of Inspire Brands, Inc. The merger was approved and subsequently consummated before the open on December 7, 2018. As a result, each existing SONC Common Share will be converted into the right to receive \$43.50 net cash per share.

CONTRACT ADJUSTMENT

DATE: December 7, 2018

NEW DELIVERABLE PER CONTRACT: \$4,350.00 Cash (\$43.50 x 100)

Settlement in SONC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Sonic Corporation options whose expiration dates are after 12-21-2018 will have their expiration dates advanced to 12-21-2018. Expiration dates occurring before 12-21-2018 (e.g., Flex options) will remain unchanged.

All Sonic Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: SONC Existing Expiration: All months New expiration date: 12-21-2018

Existing American-style Sonic Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
