The Options Clearing Corporation (OCC) has been informed that Statoil ASA (STO) will change its name, trading symbol and CUSIP to Equinor ASA (EQNR), CUSIP 29446M102. As a result, option symbol STO will also change to EQNR effective at the opening of business on May 17, 2018.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol EQNR commencing May 17, 2018.
