Swift Transportation Company, Inc. (SWFT) has announced a 0.72-for-1 reverse stock split and name/symbol/CUSIP change in conjunction with the Knight Transportation, Inc. (KNX) merger. As a result of the reverse stock split and name/symbol/CUSIP change, each SWFT Class A Common Shares will be converted into the right to receive 0.72 (New) Knight-Swift Transportation Holdings Inc. (KNX) Class A Common Shares, CUSIP 499049104. The reverse stock split and name/symbol/CUSIP change will become effective before the market open on September 11, 2017.
