On January 30, 2018, Gotham Merger Sub, Inc., a wholly owned subsidiary of Meredith Corporation, completed its tender offer for Time Inc. (TIME) Common Shares. The subsequent merger was completed before the open on January 31, 2018. As a result, each existing TIME Common Share will be converted into the right to receive \$18.50 net cash per share.

CONTRACT ADJUSTMENT

Settlement in TIME options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Time Inc. options whose expiration dates are after 02-16-2018 will have their expiration dates advanced to 02-16-2018. Expiration dates occurring before 02-16-2018 (e.g., Flex options) will remain unchanged.

All Time Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: TIME Existing Expiration: All months New expiration date: 02-16-2018

Existing American-style Time Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.

Adjustment decisions are based on information available at the time and are subject to change as additional information becomes available or if there are material changes to the terms of the corporate event(s) occasioning the adjustment.
