Teekay Tankers Ltd. (TNK) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each TNK Class A Common Share will be converted into the right to receive 0.125 (New) Teekay Tankers Ltd. Class A Common Shares. The reverse stock split will become effective before the market open on November 25, 2019.

DELAYED SETTLEMENT

The TNK component of the TNK1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the TNK1 deliverable until the cash in lieu of fractional TNK Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
