As a result of the reverse stock split, each TRXC Common Share will be converted into the right to receive approximately 0.076923 (New) TransEnterix, Inc. Common Shares. The reverse stock split will become effective before the market open on December 12, 2019. Fractional shares will be rounded up to the next whole share.
