The Options Clearing Corporation (OCC) has been informed that Vringo, Inc. (VRNG) will change its name, trading symbol and CUSIP to FORM Holdings Corp. (FH), CUSIP 34634E102. As a result, option symbols VRNG and VRNG1 will also change to FH and FH1, respectively, effective at the opening of business on May 9, 2016.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols FH and FH1 commencing May 9, 2016.
