BACKGROUND

On October 1, 2020, Shareholders of Vivint Solar, Inc. (VSLR) voted concerning the proposed merger with Sunrun Inc. (RUN). The merger was approved and subsequently consummated before the open on October 8, 2020. As a result, each existing VSLR Common Share will be converted into the right to receive 0.55 RUN Common Shares.
