Vital Therapies, Inc. (VTL) has announced a 1-for-40 reverse stock split and a name/symbol/CUSIP change. As a result of the reverse stock split and name/symbol/CUSIP change, each VTL Common Share will be converted into the right to receive 0.025 (New) Immunic, Inc. Common Shares. The reverse stock split and name/symbol/CUSIP change will become effective before the market open on April 15, 2019.
