The Options Clearing Corporation (OCC) has been informed that Intrexon Corporation (XON) will change its name, trading symbol and CUSIP to Precigen, Inc. (PGEN), CUSIP 74017N105. As a result, option symbol XON will also change to PGEN effective at the opening of business on February 3, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol PGEN commencing February 3, 2020.
