SUBJECT: Rule Change Notice—FINRA Arbitration Rules 12402, 12403 and 13403

FINRA is proposing to amend FINRA Rules 12402 and 12403 of the Code of Arbitration Procedure for Customer Disputes and FINRA Rule 13403 of the Code of Arbitration Procedure for Industry Disputes to provide that the Director of FINRA's Office of Dispute Resolution will send the list or lists generated by the Neutral List Selection System 3 to all parties at the same time, within approximately 30 days after the last answer is due, regardless of the parties' agreement to extend any answer due date. MIAX Options Rule 1107, Arbitration, incorporates by reference the rules of FINRA relating to arbitration of disputes.
