RE: Amendment to Exchange Rule 406, Long-Term Option Contracts, to Permit up to Ten (10) Long-

Term Expiration Months for SPY Option Classes

This Regulatory Circular is to inform MIAX Options Members of a rule change to amend Exchange Rule 406, Long-Term Option Contracts, which will become effective on November 16, 2018, pursuant to a notice recently issued by the Securities and Exchange Commission ("SEC"). The rule change permits the Exchange to now list up to ten (10) long-term expiration months for SPY option classes.

MIAX Options urges all Members to review this change in its entirety, which can be found in the proposed rule filing, <u>SR-MIAX-2018-28</u>.
