RE: Change to the Market for Underlying Security Used for Openings on MIAX Options, MIAX PEARL and MIAX Emerald for Symbol RUBI Effective Tuesday, June 9, 2020

Rubicon Project, Inc. ("RUBI") will transfer primary listing from the New York Stock Exchange to the NASDAQ Global Select Market ("NASDAQ") effective Tuesday, June 9, 2020. As set forth in MIAX Options Rule 503(d), MIAX PEARL Rule 503(a)(3) and MIAX Emerald Rule 503(d), the exchanges shall use NASDAQ as the "market for the underlying security" for the purpose of Openings on the Exchange.
