Pursuant to MIAX Options Rule 510(c), MIAX Pearl Rule 510(c) and MIAX Emerald Rule 510(b), MIAX Options, MIAX Pearl Options and MIAX Emerald Options will remove the following symbols from the Penny Interval Program (“Penny Program”) effective Monday, April 3, 2023.
