RE: Changes to MIAX Opening Quote Width Multiplier for Long Term Options Effective

November 1, 2013

The Exchange will increase the opening quote width multiplier to five (5) times the standard opening quote width for options with a time to expiration of nine (9) months or greater ("Long Term Option" or "LTO") for the following listed below, effective at the start of trading on Friday, November 1, 2013.

Primary Lead Market Makers ("PLMM") are reminded of the valid width quote obligation for classes the PLMM is assigned in, including LTOs, within one (1) minute following the dissemination of a quote or trade by the market for the underlying security as stated in MIAX Rules 503(e)(5) and 603(c).

MIAX Rule 406 does not provide an exemption to the requirements contained in MIAX Rule 503.
